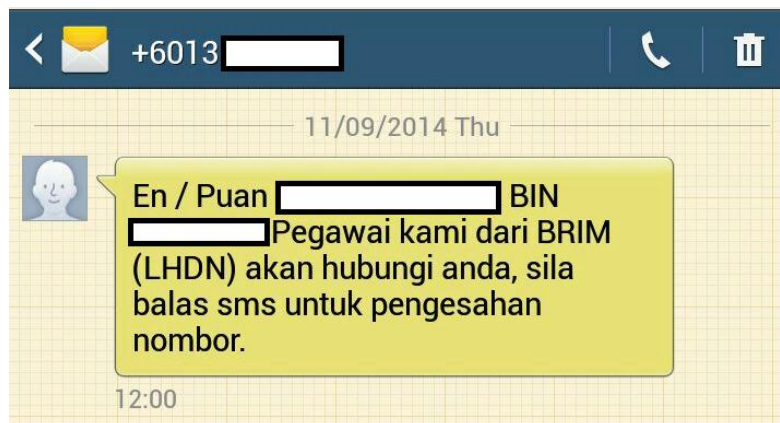
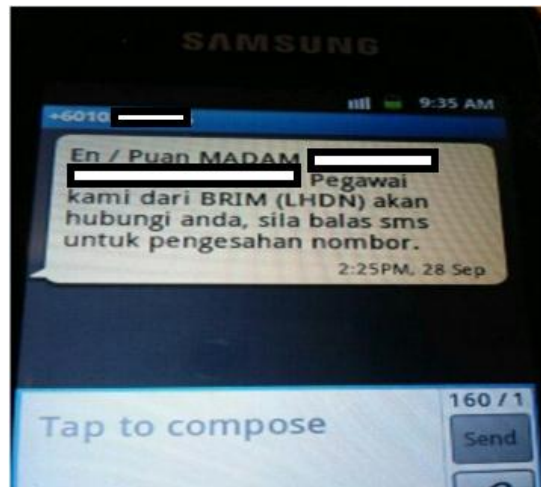

LHDNM WARNS OF FAKE E-MAIL AND SHORT MESSAGE SERVICE (SMS) ON BR1M

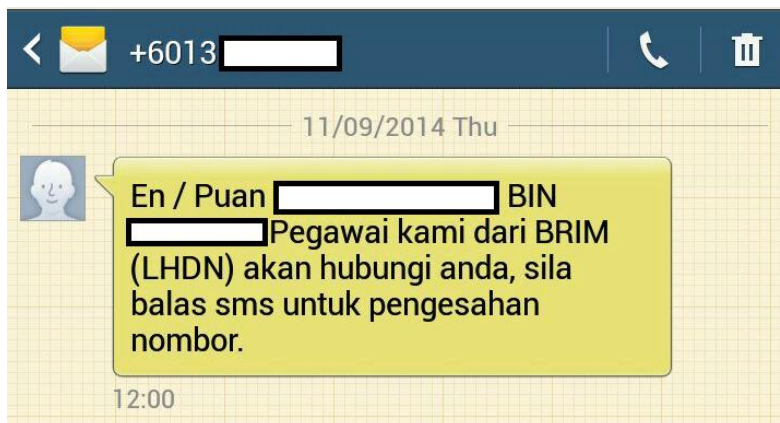
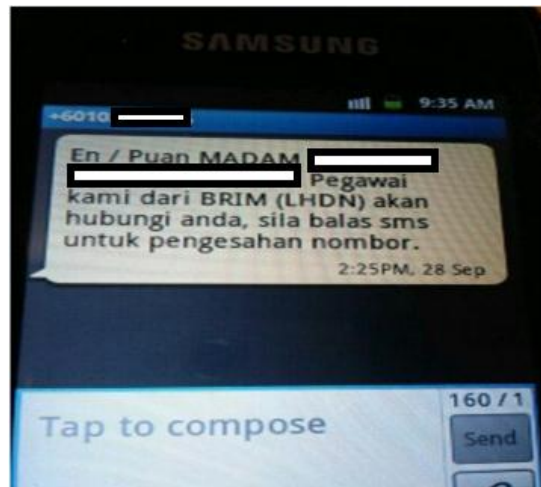
Cyberjaya, 17th October – The Inland Revenue Board of Malaysia (IRBM) has received enquiries from applicants and recipients of 1Malaysia People’s Aid (BR1M) who have allegedly received e-mails or sms regarding BR1M from an individual disguising as an IRBM officer (BR1M) offering BR1M insurance service (i-BR1M) or to check the status of BR1M approval.

IRBM confirms that we have neither issued any e-mail nor sms through any IRBM officer (as an individual) to any BR1M applicant or recipient.

Thus, we kindly advise those who have received the fake e-mail or sms to please delete it and not provide the sender with any feedback as requested.
